## The SEWP V Contract Overview

NASA SEWP V is one of only three agency contract vehicles authorized by OMB as Government Wide Acquisition Contracts (GWAC) for IT products and services. It is multi-award contract available to all Federal agencies and authorized Federal contractors. Contract details:

- Scope:** Government-Wide Acquisition Contract (GWAC) vehicle for ITC (Information Technology and Communication) and Audio/Visual Product Solutions and Related Product Services
- Delivery Dates:** Accelerera's standard for electronic delivery is 30 days after receipt of an order; delivery date commitments will be identified in our quotes to be responsive to customer requirements and aligned with commitments from our providers

### How to Order

The SEWP V Program operates under Fair Opportunity regulations as defined in FAR 16.505(b) which provides contract holders with opportunity to be considered for each order in excess of \$3,500. Agency Contracting Officers are able to direct an opportunity as a "set-aside" to various socio-economic categories. Accelerera is a Small Disadvantaged Business (SDB).

The NASA SEWP V program provides contract training for all participating agencies. This includes use of the SEWP V Quote Request Tool (QRT) that facilitates efficient processing of Requests for Quotes (RFQ's) driving competitive quotes resulting in delivery orders that meet agency strategic IT requirements. 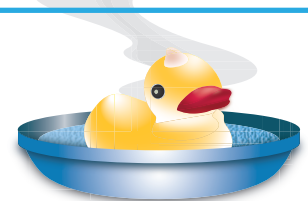
